How much does a Bess battery cost?

Do I have to pay sales tax on a Bess?

Sales tax is most relevant when considering the expense of the equipment and installation of a BESS, which is often transferred to a different owner. Most states impose a sales tax on sales of tangible personal property.

Does Bess have a tax credit for solar?

Before the Inflation Reduction Act (IRA) was enacted in 2022, BESS could only access federal tax credit funding when powered by solar and required the business-owned storage to be charged with solar 75 percent of the time.

How much does a Bess toll cost?
