Why are energy storage resources important?

Energy storage resources have become an increasingly important component of the energy mix as traditional fossil fuel baseload energy resources transition to renewable energy sources. Currently 23 states, plus the District of Columbia and Puerto Rico, have 100% clean energy goals in place.

What are energy storage technologies?

Energy storage technologies have the unique capabilities to keep the lights on when the power grid is under stress. In both Texas and California, energy storage technologies have prevented black outs during significant heatwaves--keeping people safe, power affordable, and the power on for businesses.

What is the economic value of energy storage?

One study found that the economic value of energy storage in the U.S. is \$228B over a 10 year period.²⁷ Lithium-ion batteries are one of the fastest-growing energy storage technologies³⁰ due to their high energy density, high power, near 100% efficiency, and low self-discharge.³¹ The U.S. has 1.1 Mt of lithium reserves, 4% of global reserves.³²

Why is DOE investing in energy storage?
